## Information on the conduct of the Dean's exceptional examination permissions in the second semester of the academic year 2021/2022

As per the Academic and Examination Regulations of the University of Szeged (SZTE TVSZ 12.1), "[a]ny examinations outside the examination period may be authorized individually and on request by the head of the faculty as an exceptional permission."

According to the above and taking section 10.3 of the Faculty Academic Regulations of the Albert Szent-Györgyi Medical School into consideration (in effect from June 22, 2017), students have an opportunity to be given one single exceptional examination permission made available by the Dean between July 11 and July 14, 2022 provided that they satisfy the conditions that follow.

- 1. A student is entitled to request to be granted one examination permission in a single compulsory subject in the above mentioned period that s/he did not manage to pass. Supporting documentation is not required.
- 2. In accordance with 14.2 of the Academic and Examination Regulations of the University of Szeged, students can make use of this one exceptional examination permission in the form of taking a fourth examination chance in a subject in the above period provided that they have passed every other compulsory subject in the current semester: "An unsuccessful examination may be retaken twice in a given examination period, except for instances in which the student only has a single unsuccessful examination left in the given examination period, in which case holding a permit issued by the academic office —, he or she may take a third retake examination."
- 3. In case the student exhausted the maximum number of examination chances in the subject concerned (six), no further examination chances can be granted.
- **4.** Reasons disqualifying students from being given a permission:
- having had an **unjustified absence** in an examination in the subject in question in the second semester of the academic year 2021/2022
- ➤ not having failed an examination in the subject in question at least once in the second semester of the academic year 2021/2022
- having exhausted the three Dean's exceptional permissions available to students
- having had an unjustified absence from an exceptional examination formerly granted by the **Dean**, which also entirely disqualifies the student from being given any further exceptional permissions
- > aiming to improve a successful examination in this period
- having been given a Dean's Warning or having been censured by the Student Disciplinary Committee of the University of Szeged in the second semester of the academic year 2021/2022
- ❖ Requests are to be submitted through MODULO exclusively between June 30, 2022 (Thursday), 8:00 and July 04, 2022 (Monday), 12:00 (midday). Sitting for an exceptional examination does not exempt students from attending summer practice sessions.
- ❖ Replies to requests will be announced in MODULO by **July 06**, **2022**. Formal replies on paper will not be issued.
- ❖ The departments involved will receive the list of students eligible to take an examination on **July 07**, **2022.** Only students on the list will be permitted to sit for an examination.
- ❖ Students have to pay for the examination on Neptun afterwards (1000 HUF) if it will be their 3rd or 4th examination.
