

CALL FOR APPLICATIONS International Cultural Evening 2016 Scholarship

FOR INTERNATIONAL STUDENTS STUDYING IN THE FOREIGN LANGUAGE MEDICAL, DENTAL OR PHARMACY PROGRAMS OF THE UNIVERSITY OF SZEGED

The **International Cultural Evening 2016 Scholarship** is announced to international students of the Faculty of Medicine, Dentistry and Pharmacy of the University of Szeged to act as country representatives at the International Cultural Evening 2016.

The Scholarship intends to aid students acting as country representatives to:

- host country booths
- present their countries' cultural objects, pictures, clothes
- serve their national dishes

The aim of the Scholarship

The aim of the Scholarship is to support students hosting country booths in order to enable them to showcase their countries' traditions and offer the visitors a chance to taste food from all over the world and learn more about the culture and heritage of different nations.

The Scholarship is available to international students studying in the foreign language medical, dental or pharmacy programs of the University of Szeged.

Conditions of the Scholarship

Non-recurring support:

Within the framework of the present tender the amount of the scholarship is HUF 90.000 per country representative for a maximum of 20 countries.

<u>Eligibilty</u>

International students studying in the foreign language medical, dental or pharmacy programs of the University of Szeged are eligible to submit their application to act as country representatives.



Preconditions

Students applying for the Scholarship have to submit the completed Application Form (Appendix 1).

Support period

Non-recurring support within the framework of the present tender.

Supported activity Hosting country booths, presenting cultural objects, pictures, clothes, and serving national dishes.

Support period April 16, 2016

One student is entitled to submit only one Scholarship application (for representing one country) within the framework of the present tender.

Non-eligibilty

The fund will be denied from the applicant if

- a) the application submitted contains false or deceptive data in the declaration or otherwise,
- b) the applicant deviates from the stipulations laid down in the contract while the project is ongoing without express permission,
- c) the applicant is involved in any irreconcilable condition regarding the stipulations defined in 6. § (1) and 8. § (1) of Act CLXXXI of 2007 on the Transparency of state aids provided from Public Funds (henceforth referred to as Knyt.) and does not initiate the publication of said condition by the deadline defined in Knyt..

Application procedure

All applications shall be submitted in person at the

Foreign Students' Secretariat, Faculty of Medicine University of Szeged 6720 Szeged, Dóm tér 12.

Only complete applications, submitted in hard copy are accepted.

Submission deadline April 15, 2016 12:00

All applications complying with the above requirements are accepted.

Validity of the application

All applications complying with the above requirements are considered valid.



Evaluation of the application, selection criteria

All applications complying with the above requirements are evaluated. The evaluation is based on the following aspects (TOTAL max. 15 points):

- 1. variety of presented cultural objects (pictures, clothes) max. 5 points
- 2. activities interactive activities offered max. 5 points
- 3. variety and authenticity of presented dishes max. 5 points

Applications will be evaluated continuously.

Notification

Decisions are announced continuously by the Foreign Students' Secretariat. In case of rejection, detailed justification will be provided.
